- ❖ Training our staff to recognize suspicious transactions and to fulfill all reporting obligations.
- ❖ Depending on client location, report any suspicious activities to authorities in several countries.

The Company reserves the right to collect and verify proof of identification from its clients prior to account opening and any payments of proceeds. In order to verify our identification requirements, please consult the statements on our 'Account Opening Form(s)'.

Clients should assume that all information provided to the Company is available to the competent regulatory authorities in;

- a) The country of incorporation of the Company;
- b) The country of origin of any funds transmitted to the Company; and
- c) The destination country of any funds refunded by or withdrawn from the Company.

The Company reserves the right to refuse to process a transfer of funds at any stage if it believes it to be connected in any way to criminal activities or money laundering.

The company is obliged to report all suspicious transactions and is prohibited from informing the client that they have been reported for suspicious account activity. Account misuse may result in criminal prosecution.

The Company does not want your business if your funds are sourced from criminal activities or if the nature of your account transactions is illegal in any manner what so ever.

The Company reserves the right to review and/or amend its Money Laundering Prevention Policy, at its sole discretion, whenever it deems fit or appropriate.

Our Money Laundering Prevention Policy is a policy only, it is not part of our Terms and Conditions of Business and is not intended to be contractually binding or impose or seek to impose any obligations on us which we would not otherwise have, but for any applicable laws and regulations on the prevention of the use of the financial system for the purpose of money laundering and terrorist financing, as the same may be in force from time to time and modified or amended from time to time.
